Prior to the completion of the Proposed Acquisition, Proposed Share Consolidation and Proposed Allotment and Issue of Consideration Shares, Mr. Teo is deemed to be interested in 60,567,262 shares held by Cockpit International Pte Ltd and 7,758,466 shares held by UOB Kay Hian Private Limited as nominee of Teo Kok Woon.

After the completion of the Proposed Acquisition, Proposed Share Consolidation and Proposed Allotment and Issue of Consideration Shares, Teo Kok Woon is deemed to be interested in 3,028,363 shares held by Cockpit International Pte Ltd and 25,382,303 shares held by UOB Kay Hian Private Limited as nominee of Mr Teo.

12. Remarks (*if any*):

This announcement is a replacement of an earlier notification made on 7 February 2019 ("Initial Announcement"). The Company was informed by Teo Kok Woon ("Mr Teo") that upon reconciliation of the number of shares with UOB Kay Hian Private Limited, there was an inadvertent error in the previous disclosures of shareholding under deemed interest of Mr Teo prior to completion of the Proposed Share Consolidation and Proposed Acquisition.

The correct figure under deemed interest after reconciliation but before the completion of the Proposed Acquisition of the entire share capital of Slosed! Pte Ltd, the Proposed Share Consolidation of every twenty (20) existing shares into one (1) consolidated share and the issue and allotment of an aggregate of 32,333,333 Consideration Shares in satisfaction of the Purchase Consideration for the Proposed Acquisition (collectively, the "Transactions") in the Initial Announcement should be 68,325,728 Shares (28.4%) instead of 68,250,728 Shares (28.4%).

Therefore, the correct figure under deemed interest after reconciliation and the completion of the Transactions should be 28,410,666 Shares.

There was also correction of items (5) & (6) for the issue and allotment of 24,994,380 consideration shares at S\$0.60 per share in satisfaction of the Purchase Consideration for the Proposed Acquisition and the correction of the direct interest of 24,994,380 shares after the Transactions to be reflected under deemed interest due to the issue and allotment of 24,994,380 Consideration Shares to UOB Kay Hian Private Limited as nominee of Mr Teo.

The percentage of voting ordinary shares after the Transactions is calculated based on 44,355,491 ordinary shares.
